COMMITTEE REPORTS

Retreat: Mike Anuszkiewicz reported that he is looking for a backup Retreat Leader just in case Bishop Paul needs to "back out".

Sick and Vigil: George Schmidt reported that he had sent get well cards to Victor Cap and John Kuebel. Also he reported that he had a call from Nick Hober's Wife informing him that Nick is not doing too well. George had brought a get well card to the meeting and asked all attendees to sign it so it could send to Nick.

OLD BUSINESS

- At the February meeting Mr. Pucher had requested members to actively recruit new members. No new possible members were identified.

- Richard asked attendees how many would be interested in attending the “mini-retreat” which would be given by Father Roman Galadza. Total count of members and their spouses who would attend was nine. Richard said he would have to check with Father Weiner to see if this low number would be enough to hold the retreat. If held retreat would be on Saturday March 31st from 1-3 PM.
- Scheduled harvesting of willows for Palm Sunday is Saturday March 31st starting at 9 AM. This date may change if the willows bloom early because of warmer than normal weather. Also, the palms need to be split on the same day. Mike Jackiw said that last year there was not enough help to do both the cutting of willows and splitting of palms. Richard said he would contact a few non-HNS parishioners to see if they would be willing to help.
- Spaghetti dinner is Sunday March 25th with meatballs being made on the 24th starting at 9 AM. Richard suggested that St. Ann’s Society sell sweets and drinks during our dinner. Richard will determine if they would want to also sell pop and wine during the dinner. Cost of the wine and pop would be borne by the HNS.

NEW BUSINESS

- Gene Hryhorenko asked if HNS would be willing to donate to help build a Church in Western Ukraine. Richard asked Gene to come to the next meeting with an informational packet describing this project. The Knight’s of Columbus are supporting this fund raiser.
- Next meeting is scheduled for Palm Sunday, which is the first Sunday of the month instead of the 2nd Sunday, which is Easter this year. On Palm Sunday there also will be a Children’s Liturgy. Richard said we would sit on the left side of the front of the Church and that the Children would gather around the Alter for the Gospel.
