### COMMITTEE REPORTS

#### Sick and Vigil:

## OLD BUSINESS

- **Retreat:** No one has contacted Ron to chair the retreat. Gene Sydor offered to coordinate for 2 years if someone volunteered to assume leadership as his successor. Dick Samson volunteered to assist but still need someone to assume the lead. Since no one volunteered, Gene Sydor withdraws his offer to coordinate the upcoming retreat. Deacon Steve will communicate to Father. Need to contact the retreat house to cancel reservation.
- **Spaghetti Dinner:** The check to the West Webster Fire Department was cashed. It was sent along with a letter from Father and a \$500 donation from the church. Net profit from the last spaghetti dinner was \$399.98 with a total of \$588 at the door, \$38 from the 50/50 raffle. Dick Samson suggested a single price for seniors and adults. Deacon Steve commented from another dinner where a senior was upset that they were not getting a senior discount. No resolution. St. Anne's raised about \$120 through the sale of coffee and baked goods. Question was raised as to whether or not we should resume. Stan Dabrowny suggested that St. Anne's continue to handle coffee and baked goods and the membership agreed.

## NEW BUSINESS

- **Day of Caring:** Date has been changed to June 15, 9am start. Many outdoor activities are planned. Mike Anuszkiewicz suggested that the 2 steps into the auditorium should have a railing. Weather stripping for the main doors into the church, upper and lower, was also suggested. Ron will add to the list and raise the issue with the maintenance committee.
- **Nominating Committee:** A nominating committee is needed one month before elections. Ron is asking for 1 or 2 people to volunteer for nominating committee. If no one volunteers, Ron will appoint 2 people. President and VP are 2 year terms. Ron will not be returning as president and Dc. Steve will not be returning as treasurer. Mike A. will remain as marshal, Andy F. will remain as VP as long as he is able and Mark E. will remain as secretary.
- **Rosary:** All of the rosary leaders are HNS members however only a couple of people attend rosary. At least on HNS Sundays members should make an effort to attend rosary at 9:30 am.
