### **NEW BUSINESS**

Spaghetti Dinner: The date for the spaghetti dinner will be Sunday November 6. Mark will insure a notice is placed in the bulletin. Tom will send an e-mail to the 3-4 media contacts he has. Serving time will be 11:00am to 1:30pm. We will begin preparation at 8:30 Sunday morning. The group agreed to keep prices the same: \$7 for adults, \$6 for seniors and \$3 for kids under 12. Dc.
